- **4. Approval of the Agenda** Steve moved approval, Michael seconded. Motion approved 9-0.
- **5.** Approval of the Minutes of the February 26, 2025 Meeting Mark moved approval, Tim seconded. Motion approved 9-0.
- 6. President's Report Lisa acknowledged the hard of staff and the board.
- **7. Secretary Report** There was discussion about meeting minute formatting and was decided to utilize both regular format and an AI formatted version as well.
- **8. Treasurer's Report** Mark reported that in the 24-25 fiscal year to date, the theater has lost \$8 compared to a net of \$4,296 last year; an Operations net of \$6.202 vs \$9,615; a and total gain of \$6,193 vs \$13,911 last fiscal year. Treasurer reports are attached.

9. Standing Committee Reports

- **a. Membership** Year-to-date, there are 282 memberships with 441 individuals. Lisa noted that Board elections, with Michael Beattie, Paul Andersen and Jennifer Dumpert as candidates. The Membership Meeting on April 30 will run from 6pm to 7:30pm.
- b. **Fund Development** The most recent fundraiser brought in \$6,450 with 31 attendees. A raffle brought in \$392 and a wine sale netted \$504. The event was a success.

c. Programming

Cinema The Cinema Committee has discussed raising ticket prices for first-run movies and will forward to the Finance Committee for review. Music on Film Nite is on hiatus. Cult Classics will be returning this summer. Interest has been expressed in

returning to Wednesday matinees when the time changes in November; cinema committee is reviewing the proposal.

Film Festival Committee has begun planning for the 2025 Annual Short Film Festival. Potential programs for the films were discussed, as well as increasing sponsorships; last year, sponsorships accounted for 70% of total income.

Live The Polyrhythmics show saw 135 people. The bar was \$900 and the net for the show was \$600. The blues show broke even. Third Monday Music is morphing into a series of Open Mic nights during the summer.

Telecast Recent showings of Art on Screens have been successful.

Opera The series has stopped using a satellite link and will now be streaming only.

Publicity Issues with the Independent Coast Observer have been resolved.

Film Club The season is nearly complete with a final showing of Weird Science.

Rentals Action Network and SCORE are requesting use of the Theater on June 7, 2025 for a DJ and drag show. Motion to approve by Tracy, Seconded by Blake, motion carried unanimously.

- d. **Personnel** There is a new employee in the snack bar. Setting up regular meetings of the committee was discussed, as well as employee evaluations.
- e. **Facilities** Tim reported there are no leaks on the roof; the front trees have been pruned; the carpets are slated to be cleaned; Further Reach will be laying new cable for the upgrade; there was a request that the City stripe the stalls in the parking lot.
